

## **COVID-19 and Trainee Progression in 2020 (update III) – 27 April 2020**

Please note this is primarily a UK-based document.

Trainees' wellbeing and provision remains a high priority for all and we are continuing to work to find the safest and most pragmatic solutions to the current situation. We hope the information below addresses some of the current queries and offers further support and clarity.

### **Wellbeing support**

### **ARCP management and Outcome 10**

The four Statutory Education Bodies (SEBs) have recently published guidance on the management of ARCPs during the COVID-19 outbreak and the new outcome 10 – you can find it [here](#). We are now working with the SEBs on how this guidance and the new outcome will be applied in surgery.

We hope to be able to release further details in the next few days.

### **Training Interface Group (TIG) Fellowships**

The COVID-19 pandemic continues to disrupt routine training, assessment and national selection. We understand this causes significant anxiety for all trainees, including TIG trainees who are near to, or at, the end of their training and awaiting appointment to a Consultant post.

The impact of COVID-19 on training is unfolding week by week and although we cannot form definite plans at the moment we are hoping to restart the TIG Fellowships as soon as it is reasonable and to do so with the minimum disruption to the Fellows, the training units and the TIG programme as a whole.

Training rotations in April and June have been deferred and previous JCST guidance can be found [here](#). The situation for August 2020 rotation is currently under review by the GMC and the four Statutory Education Bodies. The outcome of this decision will be shared as soon as possible.

Throughout this difficult time we realise that clinical exposure and experience during COVID-19 for trainees is variable across the whole of the UK. The Statutory Education Bodies have indicated that Out of Programme placements (which include TIG fellowships) cannot be permitted at present. This means that TIG fellowships due to start in June cannot do so. The impact of this is different for **current TIG Fellows**, those who had expected to start a TIG Fellowship in June 2020 (**new TIG appointees**) and those aspiring to apply to the Fellowship scheme in the future (**aspiring TIG applicants**).

The intention is that TIG Fellowships will remain 12 months in duration, but we will continue to review this as circumstances change and the situation evolves.

When TIG training recommences there will be a number of issues to address:

## 1. Current TIG Fellows

Many current TIG Fellows have been redeployed to their home deaneries/local offices to support the COVID-19 response. Trainees will return to their TIG placements to complete training if:

- They choose to  
AND
- They need to continue further training to complete the TIG curriculum\*

\*These trainees will have first priority when it comes to allocating TIG posts as they become available again.

If the TIG Fellow was close to the end of their TIG training before redeployment then their portfolio will be assessed by the TIG group and completion of TIG training will be considered in collaboration with the trainee. Therefore, it may not be necessary to return to their TIG placement.

A minority of TIG Fellows have stayed in their TIG placements during the COVID-19 pandemic, their training will continue until the end of their placement. Experience acquired will be assessed in the usual way.

Those trainees who elect not to return to TIG training after redeployment and who have not completed the majority of the TIG curriculum, will have recorded the clinical skills and competences achieved in the Fellowship in their ISCP portfolio. However, a certificate of completion of TIG training cannot be awarded if the curriculum has not been completed – please see point above about those near the end of their TIG Fellowship.

Any trainee leaving their TIG Fellowship either temporarily or permanently will need to inform the JCST office. The trainee will need the agreement of the host TIG unit and their home deanery/HEE local office/Training Programme Director/School of Surgery.

## 2. New TIG appointees

The start of TIG Fellowships will be delayed and the preferred training post may not be available if the TIG Fellow, who was in that post previously, needs to return to it (see above).

If a new appointee's preferred post is already occupied by a current TIG Fellow, then several issues are raised:

- The training capacity of the unit
- Funding available to cover multiple salaries\*

\*If funding is available for multiple salaries, and there is sufficient training capacity in the same unit, the two Fellows can commence their posts simultaneously.

If a training unit does not have the training capacity for multiple Fellows, then the new TIG appointee will have the option to accept a vacancy in another training unit or have the option to delay the start of their Fellowship. This would have an impact at the next recruitment round.

### 3. Aspiring TIG applicants

National selection for TIG placements due to start in late 2020 to 2021 has been delayed and the application process may be potentially changed further due to COVID-19 restrictions.

Trainees will not be disadvantaged if they have not been able to sit the intercollegiate exam during the COVID-19 crisis (even if this means the exam has to be sat during the TIG Fellowship).

The number of TIG posts and units available in 2021 may be affected by the aftermath and impact of COVID-19 on the 2020 TIG Fellows.

More information about 2021 placements will be updated as the situation becomes clearer.
